- To ensure compliance with Environmental Legislation and other requirements to which the organisation subscribes related to our environmental aspects, as well as compliance with safety and regulatory standards applicable to our activities and services.
- Address risks and opportunities based on an understanding of IYCSA's context and the expectations and needs of our stakeholders.
- o Identify and assess health and safety risks and environmental aspects within the defined scope.
- o Establish environmental, quality and health and safety objectives and targets for continuous improvement.
- Dealing with non-conformities and incidents.
- o Promote the same principles of environmental protection, health and safety and improvement to suppliers and subcontractors.
- To disseminate this policy both to company personnel and to all those who work on our behalf, as well as the objectives and achievements obtained, raising awareness and training these personnel so that they carry out their tasks in a responsible manner for the protection of the environment and health and safety.
- Promote environmental and health and safety communication with stakeholders and the consultation and participation of workers or their representatives.
- o Environmental protection as a joint initiative of Management and Staff.
- o Prevention of illnesses and accidents in all our activities and services.
- Ensure the study of disease prevention, the elimination of potential hazards within the scope of IYCSA and the reduction of accident risks in all our activities and services.
- To ensure that the environmental and health and safety principles required or demanded by our clients are taken into account and that the appropriate channels are available to make them known.
